- 2. **Seating:** Only a limited amount of reserved seating will be available in the front of the courtroom where oral argument will be conducted for counsel of record and for the litigants desiring to attend oral argument. Seating will be available on a first-come, first-served basis, both in the reserved seating section of the courtroom and in the general seating section of the courtroom.
- 3. All cell phones and recording devices shall be turned completely off when inside of the courtroom where oral argument will be conducted.
