WRIT GRANTED FOR LIMITED PURPOSE

The relator, Larry Davis, filed a writ of mandamus asking this Court to order

the trial court to rule on his motion "for a 40 day extension to file all motions and appeals." Although a copy is not included in his writ application, Mr. Davis asserts that he mailed his motion to the Twenty-Fourth Judicial District Clerk of Court on May 16, 2025. It is unclear from the application whether his motion has been filed. It is also unclear what deadline Mr. Davis is seeking an extension from.

This Court will generally afford the trial court a reasonable opportunity after

the date of filing the motion to rule before granting a writ of mandamus. *State v. Monterroso*, 21-K-650 (La. App. 5 Cir. 10/29/21) (unpublished writ disposition). According to the application, less than one week has passed from

the date Mr. Davis mailed the motion to the date he filed this writ of mandamus. We note, however, that Mr. Davis is scheduled to be sentenced on May 30, 2025. We therefore grant relator mandamus relief for the limited purpose of directing the trial court to act on relator's motion, if it has not already done so, within five days of this disposition.
