WRIT DENIED

The relator, Larry Davis, filed a pro se writ of mandamus asking this Court to order the trial court to rule on several of his motions. Mr. Davis asserts that he mailed these motions to the Twenty-Fourth Judicial District Clerk of Court on June 6, 2025, although he did not include copies in his writ application. The panel cannot determine whether Mr. Davis has filed his motions with the trial court.

Nevertheless, this Court will generally afford the trial court a reasonable opportunity to rule after the date of filing the motion before granting a writ of mandamus. *State v. Monterroso*, 21-K-650 (La. App. 5 Cir. 10/29/21) (unpublished writ disposition). According to the application, less than ten days have passed from the date Mr. Davis mailed the motions to the date he filed this writ of mandamus. For these reasons, we deny this writ application.
