In this class action suit brought by condominium owners for alleged mismanagement of insurance proceeds following damages to buildings caused by Hurricane Ida and a subsequent water event, relator defendant Strategic Claims Consultants, L.L.C. seeks supervisory review of a February 27, 2025 judgment of the trial court denying their motion for summary judgment. Upon *de novo* review of the application before us, we find there remain genuine issues of material fact that preclude granting summary judgment under La. C.C.P. art. 966. Additionally, we find the claims alleged against Strategic Claims Consultants, L.L.C. in this case to be distinguishable from those alleged against it by a different plaintiff in 24-CA-277, and therefore decline to extend that ruling to this case. Accordingly, this writ is denied.
