ORDER

This matter comes before the court on the defendant's LETTER FOR TRIAL
 TRANSCRIPTS, REQUEST FOR NAME OF APPELLATE COUNEL, AND MOTION
 FOR PRODUCTION OF TRIAL AND SENTENCING TRANSCRIPTS, STAMPED AS
 FILED ON SEPTEMBER 23, 2025.

The defendant was convicted after trial by jury on May 30, 2025 of four counts of armed robbery with a firearm. A motion to appeal, with appellate counsel appointed, was granted on June 24, 2025 and numerous transcripts and portions of the record were ordered. The defendant now files several new requests for production of trial and sentencing transcripts.

On September 25, 2025, the Fifth Circuit Court of Appeal addressed the defendant's writ of mandamus and noted that the defendant's appeal had lodged with the Court on August 29, 2025. The court also noted that after the defendant received notice of lodging from his appellate attorney, he would have ten days from the date notice was mailed to him to file a written request to view the record on appeal. For this reason, as stated by the Fifth Circuit, the defendant's remedy is to seek relief from the Court of Appeal.

The record contains communication of newly assigned appellate attorneys for the defendant. Appellate counsel will be listed for service on this order, thus providing the defendant with the name and address of his appellate representation.

Accordingly,

IT IS ORDERED BY THE COURT that defendant's motions for transcripts be and are **DENIED.**
