WRIT DENIED

Relator/defendant, Jamal Harris, filed a *pro se* petition for writ of mandamus, asserting that on December 23, 2024, he filed a motion for speedy trial, and the trial court has not set his motion for hearing. He also contends he filed a motion to quash the indictment that has not been addressed.

Mandamus is an extraordinary remedy that is used to compel the performance of ministerial duties imposed by law when ordinary means fail to provide adequate relief or when delays in obtaining ordinary relief may cause in injustice. La. C.C.P. arts. 3861-3863; Lewis v. St. John the Baptist Parish Through Cador, 22-43 (La. App. 5 Cir. 10/19/22), 351 So.3d 734, 738-739. In cases where a writ of mandamus is filed to compel a trial court to rule on a motion, this court has recognized the importance of ensuring that the trial court fulfills its duty to address pending motions. See *e.g.*, Davis v. Lopinto, 25-130 (La. App. 5 Cir. 04/08/25), 2025 WL 1042703 (unpublished writ disposition); Durall v. Darensburg, 24-141 (La. App. 5 Cir. 09/10/24), 2024 WL 4131867 (unpublished writ disposition). Therefore, in the

interest of justice, and in an effort to use reasonable diligence in determining whether the trial court has fulfilled its duty to rule on the alleged pending motions indicated in relator's writ of mandamus, this court has reviewed the trial record, as this is the most reasonable, efficient, and logical way for us to determine if relator is entitled to mandamus relief.

Defendant has failed to provide copies of the *pro se* motions that were allegedly filed and not ruled on by the trial court. Nevertheless, in the interest of justice, the record shows that another *pro se* motion for speedy trial was filed by relator on January 2, 2025, not December 23, 2024. The record indicates that this *pro se* motion was set for February 3, 2025. The February 3, 2025 minute entry indicates that counsel for defendant was present, waived defendant's presence, and requested a continuance, and the trial court reset the hearing for May 1, 2025. The minute entry further indicates that counsel for defendant stated he "will not adopt Defendant's speedy trial motion." The record indicates that defendant's motion was continued and reset several times and is currently set for November 10, 2025. Therefore, because defendant's motion was continued and reset, defendant is not entitled to mandamus relief at this time.

Additionally, as to defendant's *pro se* motion to quash, the record shows defendant has filed numerous *pro se* motions to quash over the course of this proceeding and this court is unable to determine which motion to quash the defendant contends was not ruled on or set for hearing in the current writ application. Therefore, on the showing made, relator is not entitled to mandamus relief.

Accordingly, on the showing made, this writ application is denied.
